The first day will be devoted to presenting the research work carried out by the INSigHT Research Team, with reference to the following themes: protection programs for people victims of trafficking and severe exploitation in the Veneto Region, the evolving phenomenon of begging, secondary movements in Italy (Brenner border) and Sweden and returns/reintegration programs in Nigeria. The main aim will be to share some of the main findings that emerged from the research.
